- If applicable, an Employer Parsonage Status Verification, a W-2, and an IRS Cost Claims Form (for Parsonage recipients)

If you already submitted your 2016 and 2017 Tax Returns to SINAI last spring when applying for financial aid for the 2018-2019 school year, you need not resubmit these Tax Returns. However a new Financial Aid Application must be completed.

Please note that:

- Financial aid applies to tuition only (not to transportation, meals, parent council, activity fees, etc.).
- If your 2018-2019 tuition is in arrears, your Financial Aid Application will not be reviewed.
- Divorced or separated parents must each complete a Financial Aid application.
- You must notify the Financial Aid Committee in writing within 30 days of a significant improvement in your financial situation.
- If your financial situation worsens, you may request a reevaluation of your Application.
- You must send SINAI your 2018 tax returns once filed.
